*I felt compelled to write my thoughts on that day, and chose to have it published as such to describe my view at the beginning of this pandemic, and therefore reflects my initial reaction.*



## PRESIDENT'S REPORT

As I write this article in mid March we find ourselves facing a global event whose impact may be unprecedented. Covid-19 completely changed everyday lives, perhaps in ways we were not completely prepared for, nor could have predicted. News feeds were changing hourly. Our everyday routines, in some cases, came to a halt.

While many with unrelenting faith and positivity reassured with the adage, "this too shall pass..." I found myself becoming more and more devastated watching the impact on musicians' lives. For many members, especially in the freelance scene, keeping careers in motion at the healthiest of times can be challenging. Now, faced with this pandemic, we saw livelihoods impacted more than I can recall, even considering the SARS episode.

The flurry of emails from all Locals indicated to me we were facing a situation to which clear answers were not readily available. Finding direction and an assemblage of

a move forward was almost impossible with the condition of this pandemic, particularly in not knowing when the trending curve would flatten. The newly adopted concept of social distancing, while critical in the moment, brought to my mind two very concerning thoughts; what would recovery look like for our musicians in all live sectors, and most importantly when would we expect such. The layers of uncertainty brought on by this event was something I never could have anticipated during my Presidency.

To this, I will say, the leadership, recommendations and implementations brought forth by our Executive Director Michael Murray, our staff, and Board was extraordinary. I witnessed and participated in a team forging through uncharted territory, where direction could and would change in a minute.

Our bottom line was to keep lines of communication open and deliver transparency to membership while working within the measures brought forth by our leaders, who themselves, were scrambling to respond. We decided we needed to get ahead of this and consider avenues towards potential aid and

support to membership, not just within AFM but researching such at the Federal level.

At the time of this article, this unprecedented momentum was undoubtedly still in conceptual mode. We monitored directives by the CFM, sometimes on an hourly basis, trying to process their continual strategies in the effort to collectively work together and gain a hold towards a path of resolve.

I hope by the time this article is published, we have surpassed the apex of this event. I hope that recovery is in motion. I hope the government will have figured out and imparted aid apropos to circumstance. I hope the public will make a concerted effort to support live music, from our orchestral and symphonic concerts, to our theatre shows, to our night clubs, bars and all events with live music.

Overall, health was paramount, and my hope was that members, their families and loved ones were able to overcome this and that we all were able to mitigate the impact of this wave through proactive measures.

## OFFICIAL NOTICE OF MOTIONS

### Annual General Meetings May 29, 2020

**Motion to Approve Meeting by Videoconference – To be approved at the TMA149 Annual General Meeting AND the TMA149 Building Corporation Annual General Meeting.**

That the business of TMA and the TMA Building Corporation customarily executed through in person general meetings be executable by videoconference using the motion making, voting and call for recognition technology available, and that when general meetings are held by videoconference only members attending using a computer or mobile device that can access the motion making, voting and call for recognition technology available shall be recognized, be able to make motions, and be able to vote on motions.

### Motion to Approve Suspension of Late Penalties and Reinstatement Fees

That Articles 14 — (1)(c),(2),(3),(4) and (5) of the TMA By-Laws are suspended retroactive to March 20, 2020 until a date allowed for by the AFM International Executive Board or until the Board of Directors reinstates these Articles, whichever is sooner, thereby allowing suspended or expelled members to be reinstated by simply paying for quarters missed without penalty.

## EXECUTIVE DIRECTOR'S REPORT *Michael Murray*

### To Our Members,

What an unprecedented time in your careers and in the history of the TMA. Pat Simmonds, publisher of this *Crescendo* put it best: "Founded in 1887, the TMA and its members have persevered through the Spanish Flu, two World Wars, the Great Depression, the 2008 Financial Crisis, SARS and enumerable other shocks to local, regional, national and global society and economy. We will persevere through Covid-19."

That being said it will not be easy and we will need to stick together in solidarity in order to minimize the damage Covid-19 will do to our collective economic, social, physical and mental health.

We know you are looking to the TMA for leadership in these regards. So far we have enacted increased communications, including regular e-blast updates and virtual town halls. We have been instrumental in launching SaveLiveArts.ca, a call out to government, for immediate assistance in this crisis. Some of those goals have already been achieved including the now updated Canada Emer-

gency Response Benefit which through our collective effort and the response of government can support our membership through these troubled times.

We have prepared to bring our general meetings online and we hope you will support these measures, then get comfortable with the technology at our practice meeting and attend our first electronic general meeting. At that meeting the board will move a proposal for the suspension of late fees and reinstatement fees until this crisis is over, and staff are already doing whatever they can to follow these guidelines to alleviate economic pressure on members.

We have worked with you to make reasonable arrangements with engagers for cancelled concerts and seasons and we have tried wherever we can to get a fair deal for working musicians.

We have made sure that those suffering from a Covid-19 diagnosis are supported through our benevolent funds.

Despite these efforts we know it is not enough. We are going to continue on a number of fronts. We will continue to dig deep and look at the costs of membership. We are ahead in this work as we achieved yet another year of decreases to operating expenses in 2019

and have prepared for this difficult time by ensuring efficiency and prudent spending and saving.

We will continue to support the goals stated at SaveLiveArts.ca and see how we can work with the Federation and other partners to expand our networks and influence.

We will move forward and look to organize the work that is still happening as well as the work that is most likely to return first when restrictions begin to be lifted.

We will look to hold new online sessions for you to learn about relevant union related and general music industry topics so that you can firm up your practice ahead of a reopening of our music economy.

We will continue to look for a new partnership and home for TMA for 2022, albeit with a different set of goals knowing the new reality we are living in.

We will make it through together and we all need to take advantage of this time to ensure we are more professional than ever, and ready for a new reality and for a time when live music can again be a regular part of our lives.

The meeting was called to order by President Cara at 11:12 a.m.

Secretary Gray then conducted the Roll Call of Officers:

President Cara then welcomed the members present, declared that a quorum had been reached and read the following two Motions:

### Canadian Conference Delegates

# FINANCIAL REPORTS

## Toronto Musicians' Association, Local 149 Building Corporation Financial Statements For the Year Ended December 31, 2019

### INDEPENDENT AUDITOR'S REPORT

To the Members of Toronto Musicians' Association, Local 149 Building Corporation

#### Opinion

We have audited the financial statements of Toronto Musicians' Association, Local 149 Building Corporation (the "Corporation"), which comprise the statement of financial position as at December 31, 2019, and the statements of revenues and expenses and changes in net assets and cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of the Corporation as at December 31, 2019, and the results of its operations and its cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations.

#### Basis for Opinion

We conducted our audit in accordance with Canadian generally accepted auditing standards. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are independent of the Corporation in accordance with the ethical requirements that are relevant to our audit of the financial statements in Canada, and we have fulfilled our other ethical responsibilities in accordance with those requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

#### Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with Canadian accounting standards for not-for-profit organizations, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Corporation's ability to continue as a going concern, disclosing, as applicable, matters relating to going concern and using the going concern basis of accounting unless management either intends to liquidate the Corporation or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Corporation's financial reporting process.

#### Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with Canadian generally accepted auditing standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with Canadian generally accepted auditing standards, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
- Conclude on the appropriateness of management's use of the going concern basis

of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the entity's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the entity to cease to continue as a going concern.

- Evaluate the overall presentation, structure and content of the financial statements, including disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

## Notes to Financial Statements

Year Ended December 31, 2019

### 1. NATURE OF OPERATIONS

The Toronto Musicians' Association, Local 149 Building Corporation (the "Corporation") is incorporated under the laws of Ontario. The original purpose of the Corporation was to maintain a building and other investments for the members of the Toronto Musicians' Association, Local 149. The Corporation is exempt from income tax under paragraph 149(1)(l) of the Income Tax Act.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of presentation

These financial statements are the representation of management and have been prepared in accordance with Canadian accounting standards for not-for-profit organizations in Part III of the CPA Canada Handbook.

#### Revenue recognition

Income from the investment is recorded when earned. The income is earned throughout the year based on distributions from the mutual fund, which can include capital gains, dividends, and interest.

#### Financial instruments

The Corporation initially measures its financial assets and financial liabilities at fair value. The Corporation subsequently measures all its financial assets and financial liabilities at amortized cost, with the exception of investments which are measured at fair value.

The financial liabilities measured at amortized cost include accounts payable.

### 4. RELATED PARTY BALANCES AND TRANSACTIONS

Amounts due to the Toronto Musicians' Association, Local 149 American Federation of Musicians (the "Association"), which is under common membership control, are unsecured with no specific repayment terms. During the year, the Corporation paid administration fees of \$9,509 (2018 - \$9,509) to the Association. In addition to the administration fee the Corporation also paid \$15,258 (2018 - \$31,579) of interest on the balance owing to the Association. These transactions are in the normal course of operations and are measured at the exchange amount, which is the amount of consideration established and agreed to by the related parties.

### 5. FINANCIAL INSTRUMENTS

The Corporation is exposed to various risks through its financial instruments and has a comprehensive risk management framework to monitor, evaluate and manage these risks. The following analysis provides information about the Corporation's risk exposure and concentration as of December 31, 2019.

#### Market risk

The Corporation is exposed to fluctuations in equity markets on its investments which are invested in income funds consisting of fixed income instruments and stocks of various publicly traded entities.

It is management's opinion that the Corporation does not have significant exposure to interest rate, currency, credit or liquidity risks on its financial instruments.

### 6. SUBSEQUENT EVENTS

Subsequent to the year end, on March 11, 2020, the World Health Organization characterized the outbreak of a strain of the novel coronavirus ("COVID19") as a pandemic which has resulted in a series of public health and emergency measures that have been put in place to combat the spread of the virus. The duration and impact of COVID19 are unknown at this time. It is not possible to reliably estimate the impact that the length and severity of these developments will have on the financial results of the Corporation in future periods. The Corporation continues to closely monitor and assess the impact on operations.

As a result of the unprecedented COVID-19 pandemic and the related stock market downturn, the Corporation's investment portfolio has suffered a decline. On December 31, 2019, the investment portfolio had an unrealized gain of \$166,859. On March 31, 2020, the investment portfolio had an unrealized loss of approximately \$90,688. The Corporation has established a target mix of investment instruments designed to achieve an optimal return within reasonable risk tolerances while preserving capital. It is the opinion of management that the impact on the investment portfolio will be mitigated as the world's economies return to their normal levels.

#### Opinion

We have audited the financial statements of Toronto Musicians' Association, Local 149 American Federation of Musicians (the "Association"), which comprise the statement of financial position as at December 31, 2019, and the statement of changes in net assets, operations and cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of the Association as at December 31, 2019, and the results of its operations and its cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations.

#### Basis for Opinion

**Notes to Financial Statements**  
**Year Ended December 31, 2019**

**1. NATURE OF OPERATIONS**

The Toronto Musicians' Association, Local 149 American Federation of Musicians (the "Association") is an association whose membership is comprised of musicians and whose objects are to secure improved conditions for members through collective bargaining negotiations and other economic initiatives, and to contribute to the well-being of the community at large. The Association has union status under the Ontario Labour Relations Act and is therefore exempt from income taxes under section 149(1) (K) of the Income Tax Act.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of presentation**

These financial statements are the representation of management and have been



prepared in accordance with Canadian accounting standards for not for profit organizations in Part III of the CPA Canada Handbook.

#### Revenue recognition

The Association follows the deferral method of accounting for dues and fees. Work dues, annual dues, contract service fees, contract fees and other revenue are recorded as revenues upon performance of the related service. All revenue is recognized when collection is reasonably assured. Dues and fees received in advance are recorded as deferred revenues until such time as they are earned.

Interest income is recognized on a time proportion basis.

#### Restricted net assets

Net assets which are internally restricted for benevolence are amounts received by way of donations that can only be disbursed for dues for lifetime members who require financial assistance in order to pay their annual dues.

Net assets which are internally restricted for health, education and welfare are for the purpose of providing financial assistance to pay sick benefits for disabled, ill or incapacitated members.

Net assets which are internally restricted for member assistance are for the benefit of members at the discretion of the Member Assistance Fund Committee.

Net assets which are internally restricted for contract defence are for the purpose of guaranteeing scale fees on engagements performed by members of the Association and providing financial relief to members when a purchaser of musical services fails to make payment for a contracted engagement.

#### Financial instruments

The Association initially measures its financial assets and financial liabilities at fair value. The Association subsequently measures all of its financial assets and financial liabilities at amortized cost.

The financial assets subsequently measured at amortized cost include cash and cash equivalents, cash held in trust and accounts receivable. The financial liabilities measured at amortized cost include accounts payable and funds held in trust.

#### Cash and cash equivalents

The Association considers all cash and highly liquid investments purchased with an initial maturity of 90 days or less to be cash and cash equivalents.

#### Capital assets

Capital assets are stated at cost less accumulated amortization. Capital assets are amortized over their estimated useful lives at the following rates and methods:

Computer equipment	20%	straight line method
Computer software	20%	straight line method

The Association regularly reviews its capital assets to eliminate obsolete items.

#### Foreign currency translation

Foreign currency accounts are translated to Canadian dollars as follows:

At the transaction date, each asset, liability, revenue and expense is translated into Canadian dollars by the use of the exchange rate in effect at that date. At the year end date, monetary assets and liabilities are translated into Canadian dollars by using the exchange rate in effect at that date. The resulting foreign exchange gains and losses are included in operations in the current year.

#### Contributed gifts

The work of the Association is supported by donated gifts in kind. If their fair value can be reasonably estimated, these amounts are recorded in these financial statements at their fair value at the date of contribution.

#### Use of estimates

The preparation of financial statements in conformity with Canadian accounting standards for not-for-profit organizations requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements, and the reported amounts of revenue and expenses during the reporting year. These estimates are reviewed periodically and adjustments are made to revenues and expenses as appropriate in the year they become known. Such estimates include the collectability of accounts receivable and useful life of capital assets. Actual results could differ from those estimates.

### 8. AMERICAN FEDERATION OF MUSICIANS' REMITTANCES

The American Federation of Musicians is entitled to 0.55% of symphonic employment scale wages, 1.75% of electronic media scale wages excluding sound recordings, and 1.5% of sound recordings wages earned by the Association's members. It is also entitled to per capita taxes of \$12.50 for each life active member and \$16.50 for each regular, youth and student active member on a quarterly basis.

### 9. STRATFORD MUSICIANS ASSOCIATION – LOCAL 418 REMITTANCES

The Stratford Musicians' Association - Local 418 is entitled to 1% of Stratford Festival employment scale wages earned by the Association's members to be remitted upon receipt of related work dues. This amount has been shown on a net basis as part of work dues.

### 10. COMMITMENT

The Association leases premises under a long term lease that expires on January 31, 2022. Future minimum lease payments as at year end are as follows:

### 11. EMPLOYEE FUTURE BENEFITS

The Association contributes to a multi-employer pension plan, the Musicians' Pension Fund of Canada, with the expense for this plan equal to the Association's required contribution for the year. Pension expense for the year totaled \$60,424 (2018 - \$65,666).

The pension plan is a defined benefit plan to members as retirement benefits are based on the member's contributory service, however the plan is considered to be a defined contribution plan to the Association since contributions are limited to amounts contractually agreed and the Association is not required to fund actuarially determined funding deficiencies that may occur.

### 12. FINANCIAL INSTRUMENTS

The Association is exposed to various risks through its financial instruments and has a comprehensive risk management framework to monitor, evaluate and manage these risks. The following analysis provides information about the Association's risk exposure and concentration as of December 31, 2019.

#### Credit risk

Credit risk is the risk that one party to the financial instrument will cause a financial loss for the other party by failing to discharge an obligation. The Association's cash and cash equivalents, accounts receivable, and amounts due from Toronto Musicians' Association, Local 149 Building Corporation are subject to credit risk. The Association limits its exposure to credit risk by maintaining cash and cash equivalents with major financial institutions. Management does not believe its exposure to credit risk is significant with Toronto Musicians' Association, Local 149 Building Corporation due to the Corporation's credit worthiness. This balance is also supported by investment holdings. There was no impairment allowance recorded against accounts receivable.

#### Liquidity risk

Liquidity risk is the risk that the Association encounters difficulty in meeting its obligations associated with financial liabilities. Liquidity risk includes the risk that, as a result of operational liquidity requirements, the Association will not have sufficient funds to settle a transaction on the due date; will be forced to sell financial assets at a value, which is less than what they are worth; or may be unable to settle or recover a financial asset. Liquidity risk arises from accounts payable and accrued liabilities, and commitments.

The Association continues to focus on maintaining adequate liquidity to meet operating working capital requirements and capital expenditures. The Association's cash and cash equivalents are sufficient to meet current liabilities as they come due.

#### Currency risk

Since the Association collects work dues and makes purchases denominated in United States dollars, it is exposed to currency risk due to fluctuations in foreign exchange rates. The Association does not use derivative instruments to reduce its exposure to currency risk.

Balances denominated in foreign currencies (shown below in Canadian dollars) that are considered financial instruments are as follows:

It is management's opinion that the Association is not exposed to significant market, interest rate or other price risk on its financial instruments.

### 13. RELATED PARTY BALANCES AND TRANSACTIONS

The Toronto Musician's Association, Local 149 Building Corporation (the 'Corporation') is incorporated under the laws of Ontario, for the purpose of maintaining a building for the members of the Toronto Musicians' Association. The Corporation is exempt from income tax under paragraph 149(1)(l) of the Income Tax Act and its accounts are prepared in accordance with Canadian accounting standards for not-for-profit organizations.

Amounts due from the Corporation, which is under common membership control, are unsecured and non-interest bearing, with no specific repayment terms. The Association has agreed not to demand repayment before January 1, 2021.

In fiscal 2018, the Association received administration fees of \$9,509 (2018 - \$9,509), recorded at their exchange amount, from the Corporation. In addition to the administration fee, the Corporation also paid \$15,435 (2018 - \$31,722) of interest on the balance owing to the Association.

## MAF COMMITTEE

In my last article published in the January edition of *Crescendo*, I noted this leap year's palindromic date 02-02-2020 and hoped it would be "a special year." Little did we know how the next months would evolve. With the arrival of COVID-19 there has been devastation throughout the world - to our health, our global economy and to life as we knew it. Many of us contemplate whether our daily lives will ever return to our previous, pre-pandemic 'normal,' as we cope with stressors at a new level.

Yet, at times like these our innate desire to help others comes forth with gestures — small and large — aimed at helping our community. There have indeed been many remarkable moments. We have seen communities pull together to show support for one another. People have visited elderly and vulnerable neighbours, using safe social distancing to deliver food and help offset loneliness. Families with children are learning a new version of home-schooling and spending valuable time together. Health care and other front-line personnel are working tirelessly to save lives while placing their own on hold to ensure the safety of others.

As a community of artists addressing financial losses and unknown futures, we also see remarkable gestures of outreach through streamed concerts, fundraising efforts, and continued creativity, that are intended to inspire and help us cope with this unimaginable situation.

However, we should also remember that for some individuals enormous challenges are not new. Indeed there are many people worldwide who were already facing serious health issues, financial crises and isolation.

Established before the pandemic, many charitable organizations worldwide have supported their communities. For artists, the Actor's Fund of Canada and the Unison Benevolent Fund continue to stand by artists and provide support to an unprecedented number of applicants. For unionized musicians, the Lester Petrillo Memorial Fund for Disabled Musicians provides modest financial aid to individuals on an emergency basis and should be applied for through the union local.

TMA members in good standing with long-term illness may also apply for assistance from the TMA Health Education and Welfare Fund (HEW), and TMA Member Assistance Fund (MAF). For eligible applicants, HEW covers the first 12 weeks of illness and MAF the second 12 weeks. Resulting from a two-year collaborative effort involving a Policy and Procedures Committee, MAF Committee, TMA Staff, and spearheaded by the Executive Director, the application process for these two funds was streamlined into the TMA Benevolent Fund Application and funding was increased. A letter from your Medical Practitioner is also required.

TMA Life Members who are eligible may apply to have their TMA Annual Dues paid from the Life Member Benevolent Fund.

## MPTF COMMITTEE

### Jay Boehmer

MPTF has just released their budget for all locals for the coming year and I am pleased to report some good news. The allocation for the 2020-2021 fiscal year, beginning May 1, is \$53,210. An increase of 82% from last year's allocation of \$29,191.

Local 149 was able exhaust the current year's allocation as well as an additional \$2,214 for a total of \$31,405. (MPTF had some surplus funds and they encouraged me to keep sending applications to their office.) We also accessed an additional \$3,522 for the MusicianFest seniors program where MPTF contributes 100% of the cost for a select number of solo performances.

Total performances for the 2019-2020 fiscal year was 102. (Total MPTF performances for 2018-2019 was 86.) The COVID-19 virus situation complicated things greatly in my department. Seven performances were cancelled or postponed but MPTF has agreed to honour these grants. An additional four performances were cancelled outright.

The TMA was approved for a grant of \$10,000 for Educational Performances funded 100% by MPTF. We had hoped to fund 13 performances but it was difficult with the labour situation between the teachers and the Government of Ontario. We had seven performances confirmed to occur by April 30 but only one actually took place before the quarantine. Fortunately, MPTF has agreed to pay out the remaining six performances. The total grant accessed for the Educational Initiative was \$4,515.

Kudos to MPTF for their support during this time as well as Grant Manager Samantha Ramos in New York.

# CALL FOR NOMINATIONS

Nominations for TMA Officers to the Board of Directors for the term 2021-2023 will take place at the TMA General Meeting on Friday, October 23rd, 2020. The following is the Nomination Procedure as provided for under the Association By-Laws governing Election of Officers, subject to approval of proposed By-Law changes to enable online voting (see Official Notice of Motion, p. 3).

- Art.53 (1) The Officers of the Association shall be elected for a term of three years.
- (2) (a) Members shall be eligible to stand for election as President, Vice President, Secretary or Treasurer provided they have served on the Board of Directors and have completed two years in office.
- (b) Members shall be eligible to stand for election to the Board of Directors of the Association provided they are in good standing and have completed one year of membership in the AFM.
- (c) A member who has been expelled cannot hold office in the Association until at least two years after reinstatement.
- (3) The election of Officers shall take place on the Monday immediately preceding the regular General Meeting in December (Dec. 14, 2020) and for the purposes of these election procedures is designated as ELECTION DAY.

- Art.54 The nomination of candidates for office will take place at the regular General Meeting in October immediately preceding the election (Oct. 23, 2020) and:
- (a) shall be made in documented form,
- (b) shall name the person nominated and office sought and be signed by ten (10) members in good standing,
- (c) shall be delivered to the Secretary when called for at the meeting,
- (d) unless the nominee accepts in person or in writing, the nomination is unacceptable, and
- (e) at the conclusion of the nominations, the order of the candidates' names on the ballot will be chosen by lot.
